
Please be informed that upon evaluation by the PALECO Screening Committee of the Certificate of Candidacy and supporting documents filed by a lone applicant-candidate for the forthcoming District VI (Municipality of Narra) Board Directors Election, there was a failure to comply all the prescribed requirements for a qualified candidate.

The evaluation was made pursuant to Article IV, Section III of the PALECO By-Laws and Article II of PALECO Election Code which is derived from Rule III of the Newly Amended Implementing Rules and Regulations of Republic Act No. 10531 otherwise known as the National Electrification Administration Reform Act of 2013.

In view of the above, the election set on September 10, 2022 for District VI will not push through. We shall announce the new election date and the call for the application for Candidacy.
