Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy-five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- Interested bidders may obtain further information from **Schools Division Office of Palawan- Gov. Salvador P. Socrates Gov’t. Center, Bancao Bancao, Puerto Princesa City** and inspect the Bidding Documents at the address indicated herein for issuance of Bidding Documents during office hours.

The *Schools Division of Palawan* will hold a Pre-Bid Conference<sup>1</sup> on **November 23, 2022 at 9:00 AM** at the **Conference Room, Ground Floor, DepEd Building, Schools Division Office of Palawan, Gov. Salvador P. Socrates Gov't. Center, Bancao Bancao, Puerto Princesa City** and/or through video conferencing or webcasting via **google meet** [meet.google.com/ocj-qesh-crw](https://meet.google.com/ocj-qesh-crw), which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat through manual submission on or before **December 5, 2022 at 9:00 AM at SDO Palawan - Bids and Awards Committee Secretariat 2<sup>nd</sup> Floor, DepEd Building, Gov. Salvador P. Socrates Gov't. Center, Bancao Bancao, Puerto Princesa City.**

**Late bids shall not be accepted.**

9. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
10. Bid opening shall be on **December 5, 2022, 9:00 in the morning** at **Conference Room, Ground Floor, DepEd Building, Schools Division Office of Palawan, Gov. Salvador P. Socrates Gov't. Center, Bancao Bancao, Puerto Princesa City.**
11. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity. Only one (1) representative per bidder will be allowed to enter the premises.

**For the purpose of constituting a quorum**, both the physical and virtual presence of the BAC and TWG members shall be considered pursuant to GPPB Resolution No. 09-2020.

The **DepEd, Schools Division Office of Palawan** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
