Bids received in excess of the ABC for each item shall be automatically rejected at bid opening.

1. The **Schools Division of Palawan** now invites bids for the above Procurement Project. Delivery of the Goods must be within **thirty (30) calendar days** after the receipt of notice to proceed. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
3. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

The Schools Division of Palawan will hold a Pre-Bid Conference¹ on **December 16, 2022, at 9:00 AM** at the **Conference Room, Ground Floor, DepEd Building, Schools Division Office of Palawan, Gov. Salvador P. Socrates Gov’t. Center, Bancao Bancao, Puerto Princesa City** and/or through video conferencing or webcasting *via google meet*, which shall be opened to prospective bidders.
7. Bids must be duly received by the BAC Secretariat **through manual submission at the office address indicated below on or before December 28, 2022 at 9:00 AM**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **December 28, 2022 at 9:00 AM** at the given address below: **Conference Room, Ground Floor, DepEd Building, Schools Division Office of Palawan, Gov. Salvador P. Socrates Gov’t. Center, Bancao Bancao, Puerto Princesa City**.

Bids will be opened in the presence of the bidders’ representatives who choose to attend the activity.
